Election One: Election of Clergy for Standing Committee ***Two Clergy Needed for 3-Year Term***

The Very Rev. Karl Burns (Church of Our Saviour, John's Island)

The Very Rev. Karl Burns is starting his fifth year as rector at The Church of Saviour and has



served as rector of All Saints, Florence, Middle School Chaplain at Porter Gaud, associate rector at The Church of

the Good Shepherd in West Ashley, and curate at Old St. Andrews. Karl's diocesan responsibilities have included serving on the Standing Committee (president 2018), Diocesan Counsel, St. Christopher Camp and Conference Advisory Board (Board Chair for four years). He currently is serving on the Commission on the Ministry, and as chairperson for the Diocesan Nominations Committee and as Dean of the West Charleston Deanery. Karl has served as a spiritual director for Cursillo, is active in Men's Ministry and recently led a pilgrimage to the Holy Land. His connections to the diocese began as a volunteer youth leader, and then as fulltime youth minister for seven years. Karl and his wife, Susan, enjoy being empty-nesters and spoiling their four grandchildren.

The Rev. Mary Ellen Doran (St. David's, Cheraw and St. Paul's, Bennettsville)

The Rev. Mary Ellen Doran is the rector of St. David's, Cheraw and the vicar of St. Paul's, Bennettsville, where she has



served the past three years. Before moving to Cheraw, Mary Ellen served as the assistant rector at the

Church of Our Savior on Johns Island. Mary Ellen has served as a member of Diocesan Council, is a member of the Diocesan Clergy Retreat leadership team, and currently is serving on the Search Committee for a Bishop Coadjutor. Mary Ellen and her husband, Keith, have been married for 26 years and have two grown daughters, Amanda and Madalaine. They also have two grandchildren, Reagan and Kinley.

The Rev. Denman Isgett (St. Matthias, Summerton)

The Rev. Denman Isgett has served as Rector of St. Matthias' Church, Summerton, since 2017.



He was raised in rural Calhoun County and, in his youth, served as an acolyte and in various youth ministries at St. Matthew's Parish (Ft.

Motte). Though hearing a call to ordained ministry at an early

age, he instead pursued a career in agriculture, graduating from Clemson University (B. S. '95, M. S. '97). A successful career of Agri-business management would not silence the call to ordained ministry, and so he began the process of discernment to ordained ministry (as a member of St. John's Church, Florence). Working full time while attending Gordon-Conwell Theological Seminary, with the support of his wife (of 22 years), Michelle, and their two daughters Hailey (18) and Emily (15), he graduated in 2017 and was ordained the same year. Passionate for witnessing Christ's love through the Anglican way, Denman has served on Diocesan Council the past three years.

The Rev. Tyler Prescott (Good Samaritan, Summerville)

The Rev. Tyler Prescott is the church planter at Good Samaritan Anglican Church, a growing church plant on the west side of Summerville commissioned by St. Paul's, Summerville, in 2018. Prior to planting Good Samaritan,



Tyler served as Associate Rector at St. Paul's for eight years. Tyler has served on various Diocesan committees including Diocesan Council, the Board of Directors for St. Christopher, and the Board of Examining Chaplains. Prior to seminary and ordination, Tyler worked as a structural engineer and worshipped with his family at St. Michael's Church, Charleston. Tyler and his wife, Lanier, have seven children.

The Rev. Rob Sturdy (St. Alban's Chaplaincy, The Citadel)

The Rev. Rob Sturdy is the Anglican Chaplain to the Citadel, where he oversees the St. Alban's Anglican Chapel.

at Wycliffe Hall, Oxford University. He was ordained in The Anglican Diocese of South Carolina and has served in South Carolina since. He is an associated researcher for the ETF, where he serves on the Institute for Post-Reformation Studies. He also serves as an assistant professor of Systematic Theology for the Dmin program at Trinity School for ministry in Ambridge, PA. Rob is married to his high school sweetheart, Stephanie. They have two children, David and Genevieve. He is a passionate evangelist and a strong advocate for ministry to college students and young adults.

Mrs. Robin Downing
(All Saints, Florence)

Mrs. Robin Downing joined Saint Matthew's, Darlington, in the spring of 1995. While there she served on the Vestry, was a Lay Reader, a member of the Altar Guild and a President of the ECW from 2010-2012. In 2017, she transferred to All Saints Anglican Church in Florence. She is an active member of the prayer team and assists in getting communion packets to church members who participate in services online. Pre-covid-19, she was a Sunday School teacher for the upper elementary grades. From 2010-2015, she served as a Deanery Director of the PeeDee for the Women of The Anglican Diocese of South Carolina. Her job was to reach out to the various churches in the PeeDee to provide support if needed, as well as to let other churches know what other women were doing in their churches to meet the needs of their churches and community. During this time, she also served on the board of the Women of the Anglican Diocese of South Carolina, assisting in the reorganization of the group during the transition period and helping to plan for the yearly women's retreat at St. Christopher. She writes, "I have witnessed this Diocese move through difficult uncharted waters only to come out as a strong church with a clear mission: to make Biblical Anglicans for a global age. Because of these experiences I have had on the local level and on the Diocesan



level, I would like to serve on the standing committee to make sure this mission continues."

Mr. George Greene
(St. Philip's, Charleston)

Mr. George Greene grew up in a Christian family. He accepted Jesus as his Savior when he was 35. He and his wife, Molly, were married 49 years until she died unexpectedly in July 2019. They had three children, Jeni (seven



children), George IV (two children), and John Christian who died unexpectedly in 1984. George holds a PhD in Chemical Engineering. With Molly he co-founded an environmental consulting company which they ran for 20 years. He and Molly co-founded Water Mission, a Christian engineering ministry that provides safe water and shares the Gospel with people in need around the world. He also founded the Global Water Center, a Christian ministry that is developing global capacity to bring safe water to 2.2B people. He currently serves as Executive Chairman of both ministries. He is a member of St Philip's and has served as Junior Warden, Senior Warden, Chairman of the Restoration Committee, and other roles. He has not served at the diocesan level.

Mr. Bill Lyles
(St. Michael's, Charleston)

Mr. Bill Lyles is a member of St. Michael's Church, where he has been active since 1994.



At St. Michael's, Bill has served two separate terms as Sr. Warden and two separate terms as Jr. Warden, along with serving as Secretary to

the Vestry. He also has been the Chairman of the Finance Commission and served as a member of the Evangelism Commission. He is a member of the Order of St. Luke and has served as a prayer minister. Bill acted as the lay coordinator for the Alpha Course and was part of the team that started Alpha in the Workplace for St. Michael's. At the Diocesan level, Bill has served two separate terms on the Standing Committee. He has been a member of the Ecclesiastical Court. From 1997 through 2014, Bill served as a Diocesan Delegate for St. Michael's, including serving as a Delegate for Bishop Lawrence's election. Bill acted as the Lay Rector for Cursillo 154 and has been a small-group leader at the Diocesan Men's Conference and Marriage Conference. Bill and his wife, Jeanne, have been married for 23 years. They have two children, William (22) and Mason (20).

Mr. Ed Mitman
(Epiphany, Eutawville)

Mr. Ed Mitman lives in Summerton with his wife Tracy. They have two adult sons who both reside in South Carolina. After a successful career in federal law enforcement, he retired in January 2010. Following his retire-

The Rev. Luke Deman
(St. Timothy's, Cane Bay,
Summerville)

The Rev. Luke Deman is the Rector at St. Timothy's Church in Cane Bay. He was a member of the leadership team that planted the Church, and was called back after attending seminary at Trinity School for Ministry in Pennsylvania. He and his wife Jennifer have been married for 13 years, and have two children, Oscar (8) and Marcella (3). Before his call to ordained ministry, he worked in the software industry at Blackbaud on Daniel Island. Before planting St. Timothy's, he was an active member at St. Paul's, Summerville, serving on the vestry and assisting with the Alpha program. He prays for his congregation to grow in faith, hope, and love while they participate in God's plan of rescue and redemption for the people of Cane Bay and Nexton.



The Rev. Justin Hare
(St. Philip's, Charleston)

The Rev. Justin Hare serves as assistant rector for Young Adult and College Ministry at St. Philip's Church. He grew up in the diocese at St. Michael's. The Rev. Paul Fuener
